





A Near Fine set with minor wear to the extremities and some foxing and toning to the tissue guards over the plates. Gephart 6971. Sabin 31161. A gorgeous set of Headley's history of Washington and his commanding officers, scarce in such fine condition. **\$400**

This is the second issue with sheets printed by Robert Aitken in Philadelphia combined with new sheets printed by John Dunlap in York. ADNB: "Dunlap, John", "Aitken, Robert"; Evans 16137; Hildeburn 311; Matyas 77-09a, 77-09b; NAIP 329913; Reese, The Revolutionary Hundred (48); Sabin 15545. Binding is good only with considerable rubbing and wear to the boards with significant loss to the cloth on the top and bottom of the spine (binding still secure); leaves are Very Good, "Volume II" has been worn away on title page (but perceptible with proper lighting and magnification), the leaves show occasional light foxing but are generally very clean throughout. Aitken was unable to remove his printing equipment from Philadelphia prior to the British occupation in 1777 whereas Dunlap had moved his equipment to Lancaster and thence to York, Pennsylvania while the British Army was advancing towards the city.

Agreeable to the order of the day, the Congress resolved itself, into a committee of the whole, to take into their farther confideration the declaration, and after some time the president resumed the chair, and Mr. Harrison reported that the committee have agreed to a declaration which they defired him to report.




A DECLARATION by the Representatives of the UNITED STATES of AMERICA in Congress af-

WHEN, in the course of human events, it becomes necessary for one people to distolve the political bands which have connected them with another, and to assume among the powers of the Earth, the separate and equal station to which the laws of nature and of nature's God entitle them, a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation.


We hold these truths to be felf-evident; that all men are created equal; that they are endowed, by their Creator, with certain unalienable rights; that among these are life, liberty, and the pursuit of happiness .-- That to secure these rights, governments are instituted among men, deriving their just powers from the confent of the governed; that whenever any form of government becomes defirmchive of these ends, it is the right of the people to alter or to abolish it, and to institute new government, laying its foundation on fuch principles, and organizing its powers in fuch form, as to them shall feem most likely to effect their fafety and happiness. Prudence, indeed will dictate, that governments long established, should not be changed for light and transient causes; and accordingly all experience hath shewn, that mankind are more disposed to fuffer, while evils are sufferable, than to right themselves by abolishing the forms to which they are accuftomed. But when a long train of abuses and usurpations, purfuing invariably the fame object, evinces a defign to reduce them under absolute despotism, it is their right, it is their duty, to throw off fuch government, and to provide new guards for their future fecurity. Hildeburn quotes Aitken in regard to Volume II of the journals: "I printed 800 copies of the second volumes, 50 were carried to Lancaster, and committed to the care of Mr. Dunlap. I find of the 750 other copies only 532 were delivered. I allow 218 copies as they have been lost or embessled." Matyas indicates that a comparison of the 7 copies of the issue with the York-town imprint held by the Library of Congress with the first issue Philadelphia copies shows that the type settings are identical for signatures A-3G whereas the remaining signatures reflect a new type setting (and thus are the sheets printed by Dunlap). It is generally supposed that the original sheets printed by Aitken must have been lost or damaged in the flight from Philadelphia. The upshot is that there are no more than 50 copies of the second issue with the York-town imprint. All other volumes of the Journals of Congress were printed in Philadelphia. Robert Aitken printed the first two volumes of the Journals of Congress, John Dunlap printed the third, and the ninth through the thirteenth volumes of the Journals. David Claypoole was the third printer of the Journals, printing the fourth through the eighth volumes. Dunlap was the original printer of the Declaration of Independence, printing 200 broadsides and distributing them to members of Congress. Matyas refers to the Journals as "essential for any comprehensive collection of the Revolution and early National period". 





The second edition, printed by Christopher Saur II, the first edition having been published in 1743. Saur's family immigrated to Pennsylvania from Westphalia in 1724. Saur and his father advocated for Quaker causes via their printing activities in Pennsylvania. Saur II was in charge of the bindery and of English language publications at his father's business. After his father's death, Saur II continued to publish their newspaper, their almanacs, and their religious books (bibles and hymnals, etc.). In 1773 Saur the II established a paper mill on the Schuylkill River, which would greatly increase his wealth and standing in British America. However, because of his later reluctance to participate in the American Revolution (due to his Quaker beliefs), Saur would have his house and properties sold off, and died poor. This is the first Bible printed in any European language in the Continental United States. The 1763 edition eliminated Saur I's postface and included a new Foreword. 2,000 copies of this second edition were printed. \$2,000








The series as a whole was quite popular and widely admired for its literary style and engrossing historical narrative. 




Colonel Stephen Kembel, Sir William Howe, Colonel Armand, Captain Alexander Macdonald, and Lieutenant John Charles Philip von Kraft. Philbrick, Nathaniel: "The United States Exploring Expedition 1838-1842". Sabin 103994. The U.S. expedition was designed to increase trading opportunities for the young nation in the Pacific Ocean, and to survey the West Coast after the Lewis and Clark expedition. The voyaging party started at the southern end of the Pacific, going from South America to Antarctica, then making their way to Tahiti, Fiji, and Samoa. They would then voyage to Hawaii, and would go on to survey the western coast of the United States (California, the Willamette Valley, and the Columbia River area). The volumes end on the crew's travels to the Philippines, Borneo, Australia, New Zealand, the Cape of Good Hope, and St. Helena. The first naval expedition of its kind to be funded by the U.S. Government. These volumes contain the crew's weather reports, descriptions and illustrations of aboriginal peoples, maps of the territories explored, geological diagrams, and more information the crew gathered on their expedition around the world. The expedition itself brought back 4,000 anthropological specimens, artifacts from the native tribes of Fiji, Tahiti, and California. After supervising his publications, Wilkes would run the display of the expedition's collection in Washington D.C. (originally held in the patent office). The expedition's collection would later be housed in the Smithsonian around 1858. A fascinating set on one of the most important scientific voyages undertaken by an American crew. \$750







Tom Hayden, a co-founder in Students for a Democratic Society, Black Panther Chairman Bobby Seale, David Dellinger and Rennie Davis, members of the National Mobilization Committee to End the War in Vietnam (MOBE), and John Froines and Lee Weiner (accused of making stink bombs). These men were tried on charges of criminal conspiracy and intent to incite a riot while crossing state lines. The judge presiding over the case, Julius Hoffman, was notably not impartial and he spurned most of the pre-trial motions made by the defense attorneys and acted procedurally in favor of the prosecution. The trial would last from late September of 1969 until February 18th, 1970. Eventually, seven of the eight had their convictions overturned, largely due to impropriety on the behalf of the FBI and Judge Hoffman's displayed biases against the defendants. However, Bobby Seale (the only black member of the Chicago 8) would spend four years in prison, found in contempt of the court. The Chicago 8 are known by several names, such as: "The Conspiracy 8", "The Chicago 8", and "The Chicago 7". The story of the Chicago 8 sheds light on twentieth-century police brutality, the counter-culture movement during the 1960s, and racism within America's judicial system. Britannica "The Chicago 7 Law Case". 





Dubbed "The Century of Progress", the fair celebrated the history of science, industry, and technology (with the fair's motto as "Science Finds, Industry Applies, Man Conforms"). Approximately 40 million people attended the fair. Thanks to its corporate sponsors, the fair touted consumerism and corporation -backed science. Unlike the 1893 Chicago World's Fair, there was no legislation mandating that women's exhibits be in the fair, thus women were shown only as products at the fair. However, in 1933, with the help of the NAACP, a handful of African-American state senators forced Illinois to ban racial discrimination on the World's fairgrounds, thus, when the fair continued into 1934, there were legal protections for black attendees and employees of the fair. 


